They may also choose to study in two European countries and on another continent, with, for example, such tracks as Paris-London-Shanghai (or Bangalore or Cornell), or Paris-Madrid-Adelaide, Australia. A few will choose to study in only two different countries. In addition to these assets and to the quality of student/faculty relations, ESCP Europe encourages its students to engage in healthy and enthusiastic extracurricular activities with local, national and international associations, societies, sports clubs and charities.

Thus, upon graduation, the school's students will have acquired the intellectual training and professional skills which allow them to apply for promising positions worldwide. The number of job offers our students receive and the bright career paths they then follow testify to the relevance of the education we provide.



European and International Study Tracks

Each year 400 students, from an applicant pool of 5,000, are admitted into our Pre-Master year. They come from undergraduate programmes worldwide and from French preparatory schools. To qualify for admission they take a highly competitive entrance examination. They are joined by a further 250 students, rigorously selected on the basis of a competitive entrance examination, who enter directly into the Master Course. To qualify they must be university graduates with a at least a three-year Bachelor degree or equivalent. We offer the opportunity to each student to build his/her study track based on the academic contents and the choice of the campus.

■ PRE-MASTER YEAR

The Pre-Master year is devoted to mastering the fundamentals of management. It includes introductory and advanced concepts to foster your understanding of the world of business. There are also courses in the social sciences, law, economics and foreign languages. The Pre-Master year combines requisite courses, interdisciplinary projects and an internship. Students earn a total of 60 ECTS credits for the year. Students can spend the Pre-Master year in Paris, London or Torino.

■ THE MASTER COURSE

The Master course comprises four semesters of study. Participants take between two and four years to complete the course including possible gap semesters for work experience. The Master course is designed to enable each student to determine his/her career goals and acquire the necessary knowledge, skills and experience to achieve them.

The programme, totalling 120 ECTS credits, consists of the following:

- Core courses
- Elective courses (over 140 courses to choose from)
- One or two specialisations
- Language courses
- A research project
- In-company internships

Professor of Marketing

"I hold the view that good research and teaching needs to balance practical relevance with scientific rigor. Teaching students concepts and approaches that do not have a clear and obvious relation to business problems is of limited value for me. Before joining ESCP Europe I worked for five years as a strategy consultant and my research deals

with many of the questions I faced during this period. The areas I specialised in are Customer Relationship Management (the analysis of customer information to develop appropriate relationships with them) and e-Commerce. I always try to confront students with cutting edge and up-to-date knowledge to ensure that they leave my class knowing what is going on in these areas at this very point in time, not only 5 years ago."

Professor of Finance

"A good researcher is a good teacher. For me, it seems natural to talk about my research in class. In reality the dividing line between theory and practice is thin. I use lots of practical illustrations in my classes so that students understand the theory, and learn to apply it directly and practically. I give a lot of exercises because understanding comes from experience, i.e. "learning by doing". In my research, and in the classroom, I explore the concepts. Though my area of expertise is financial markets, I am

currently working on a project in corporate finance and law, a fascinating area."



Company exposure

Case studies, internships, in-company projects, in-class lectures and instruction from visiting executives, educational partnerships with companies... These are some of the ways in which ESCP Europe prepares business managers and future executives to meet the new challenges posed by the globalisation of the economy. The Corporate Relations provides job offers, organizes company relations events and company forum.

Applied work experience

Internships are an integral part of the programme and the learning experience. They enable you to apply classroom knowledge to real-life situations and to clarify your career goals. Many students opt to take from one to four semesters off during the programme in order to gain additional in-company work experience.

It was a fascinating experience for me, coming from Spain, working in London for a French bank! It didn't take long to understand the meaning of "multi-cultural". The apprenticeship

The two-year or one-year apprenticeship of the Master in Management programme is possible on the Paris campus. It combines in-company work experience with academic coursework at ESCP Europe and includes a semester abroad at an international partner university.

5 urban campuses: learning by living abroad

Each of ESCP Europe's campuses is located in a major urban centre. All are equipped with libraries, auditoriums, comfortable classrooms and study lounges. The Paris and London campuses offer free Wi-Fi connections. The school's intranet provides a range of services from email, online directories, library databases, job and internship offers, classified ads, as well as discussion groups and sites for student clubs and associations.



Student life

A strong sense of school spirit and community is a defining characteristic of ESCP Europe. Involvement in extra-curricular activities and student associations is strongly encouraged. We consider it an essential part of personal well-being and professional development. **Student life on each of the campuses is shaped by the initiatives and activities offered by some 50 clubs and associations.** These include professional networking events, artistic and cultural events, sports tournaments (over 25 different sport activities), social events, etc.

A few examples of student organizations

The Student Union - elected by the student body – organizes and coordinates student life on-campus (parties, trips, and also company fairs and events where students can meet recruiters). It also organises an orientation weekend for new students.

The Arts Club - a student organization which offers a range of cultural activities throughout the year.

Sports Department - it runs the 30 sporting activities on offer at the school (rugby, football, rowing, volleyball, modern dance etc).

ESCP Europe Consulting - a student-run consultancy company present on all five campuses.

Absolutely - organizes numerous activities to strengthen links between students on five campuses.

Paris Tenu - publishes a guide to student life in Paris.

Fleur de Bitume - is dedicated to providing assistance to the homeless and working with young people from impoverished backgrounds.

Art Maniac - school's theatre organization

ESCP Europe offers need-based and merit-based scholarships. Some 400 scholarships and grants are awarded every year representing 1,200,000 €.

Other sources of financial aid include:

- Apprenticeship: tuition fees are covered by the student's employer (Paris campus curriculum only)
- Income from paid internships and student jobs on campus
- Bank loans at preferential interest rates
- National scholarships
- Financial aid awarded by the French Ministry of Foreign Affairs
- French government housing assistance to students in Paris

Housing

ESCP Europe helps students secure accommodation. In addition to the school's own classified ad service, ESCP Europe maintains a residence with rooms for 200 students in Paris. There are 31 rooms on the London campus.

Student cafeterias on the Paris, London and Madrid campuses provide full meals for about 3 €.

European governance

The Paris Chamber of Commerce and Industry

The Paris Chamber of Commerce and Industry (CCIP) was instrumental in establishing the *École Supérieure de Commerce* in 1819 and in creating EAP in 1973. The two schools merged in 1999 to become ESCP-EAP and became ESCP Europe in 2009. The CCIP represents the interests of over 300,000 companies in the Paris area (including in the *Hauts de-Seine*, *Seine-Saint-Denis*, and *Val-de-Marne*). Its members produce over 20% of the GNP of France. It is the largest institution of its kind both in France and in Europe. The CCIP offers a wide range of services to its member companies. In addition to defending their interests it assists them in every phase of their business development. The CCIP also plays a central role in promoting the national and international influence of the Ile de France region

The "Land" of Berlin

Since 1985, the "Land" of Berlin has contributed politically and financially to the CCIP's educational mission in Berlin. The Senate, the Land's governing body, contributes significant resources ensuring the long-term establishment of the campus in the capital city.

The Torino Chamber of Commerce


The Torino Chamber of Commerce co-founded ESCP Europe's campus in Italy and continues to play a major role in the school's development.
